1. What training or experience in preaching have you had?
2. Tell us about your sense of call to preach.
3. How do you go about preparing a sermon?
4. What is your involvement in the church and the community?
5. Share with us your Statement of Faith.

2023 Recommended honoraria for specific pastoral services by someone other than the church's own Pastor (percentages are of minimum effective salary) plus mileage at IRS rate:

- Supply preaching [in-person or virtual]: (.362%) **\$188** (plus mileage at IRS rate)
- Additional for multiple services: **\$50.00 per service** (plus mileage at IRS rate)
- Wedding: (.435%) **\$226** (plus mileage at IRS rate)
- Wedding rehearsal: (.22%) **\$114** (plus mileage at IRS rate)
- Funeral: (.435%) **\$226** (plus mileage at IRS rate)
- Home or hospital visit: (.073%) **\$38** (plus mileage at IRS rate)
- Moderate meetings [in-person or virtual]: Each meeting of Session or congregation (.22%) **\$114** (plus mileage at IRS rate)

*The church's obligation is reduced by any amount paid by the family.
