The Presbytery's churches list 5700 active members, down from and adjusted membership of 5845 on December 31, 2020. Reporting churches indicated membership gains of 160 and membership loss of 305. Of that loss, some is due to death and deletion of membership for various reasons. (5/7)

  - b. Buyer is Citylight Mosaic Church, a Nebraska non-profit corporation.

All personal property and Trade Fixtures within the Property except for the organ and all other items on the stage in the sanctuary of the Church and other items of personal property that have sentimental or historical value to the members of Westminster Presbyterian Church (the "Seller Items") shall be removed by Seller from the Property prior to Closing. The black Yamaha piano in the sanctuary of the church, all pews, tables, chairs, and kitchen appliances will not be considered Seller Items and will be transferred by Buyer at Closing. - c. Buyer delivers \$20,000 earnest money to the broker working with the Buyer, Newman Realty, no later than 48 business days after mutual acceptance of the offer for purchase.
- d. Purchase price offered is FOUR HUNDRED THOUSAND DOLLARS (\$400,000) in immediately available funds at closing of the sale of the Property minus \$20,000 earnest money or \$380,000 upon closing.
- e. Closing shall be September 30, 2022, or at a time mutually agreed upon by both parties, at a time and place which shall be designated by listing Broker and Seller.
- f. Possession shall be delivered at closing. (9/29)
- Approved the following resolution to authorize Joyce A. Faltis of Discovery Presbyterian Church/Omaha to act on behalf of Presbytery of Missouri River Valley and execute the sale of property in Wyoming: The corporation approves the sale to <u>Windmill Range</u> <u>LLC</u>, the real property of the corporation, <u>640 acres located in Niobrara and</u> <u>Converse counties in Wyoming</u>, in accordance with the terms of the contract of sale, and that Marcia Cline, <u>President and Moderator</u> of the corporation duly elected at the meeting on September 29, 2022, authorized Joyce A. Faltis, President of <u>Discovery</u> <u>Presbyterian Church, Omaha, Nebraska</u> to execute and deliver such documents. (9/29)
