1. Motion made by Rev. Dr. Michael Elliott on behalf of the Stewardship of Resources Committee to approve the sale of the Manse by Trinity Presbyterian Church, Clarinda, IA. North sixty tow (62) feet of the west one hundred fifty (150) of block two (2) of Johnson's Addition to the City of Clarinda, Page County, Iowa. Deed #4134. Information: Buyer pre-approved. Sale price \$147,500 – close June 28, 2024. The plan is to put the \$ in a CD or other related fund, for future use if the congregation gets a pastor that needs housing.
